Take notice that on September 28th, 2011, the Debtor filed for protection pursuant to the *Companies' Creditors Arrangement Act* ("CCAA"). Pursuant to the order issued by the Québec Superior Court of Justice (the 'Initial Order'), Groupe Serpone Trustee in Bankruptcy Inc. was appointed ("Monitor") by the Court.

Take note that the Initial Order granted by the court suspends all procedures against the Debtor until October 28th, 2011. A copy of the Initial Order, as well as the list of creditors is attached with this letter.

At present, creditors are not required to file a proof of claim. At the appropriate moment, we will forward the Arrangement Plan duly filed by the Debtor as well as a notice for a creditor's meeting in order that you may submit your vote.
